SCRIPTURE AND INTERPRETATION Guidelines for Contributors

- 1. Articles submitted for publication must conform to the requirements set forth below. Submissions that significantly deviate from these instructions may not be accepted or may be returned to the author before publication is considered. Each submission should be accompanied by both the *S&I* submission form (available upon request) and a statement certifying that the article has not been submitted elsewhere for publication, in any language. *S&I* does not reprint published articles except by invitation.
- 2. Only one article or short study in the field of biblical studies and in the English language may be submitted at one time. Submission must be sent electronically to ttcbr@ttgst.ac.kr either in a Microsoft Word (.doc or .docx) file or the standard Rich Text format (.rtf). The document size should be either A4 or US Letter, and formatted using double spacing and page numbers.
- 3. Copyrighted fonts for Greek and Hebrew such as Bibleworks© fonts are not accepted. *S&I* accepts SPIonic and SPTiberian for Greek and Hebrew/Aramaic fonts. Other specialty fonts must be copyright free.
- 4. Save for the specific instructions given below, the directives of *The SBL Handbook of Style* (Peabody: Hendrickson, 1999) are to be followed, supplemented by *The Chicago Manual of Style* (15th ed.; Chicago: University of Chicago Press, 2003). Preferred authorities on spelling are *Merriam-Webster's Collegiate Dictionary* (10th ed.; Springfield: Merriam-Webster, 1993) and *Webster's Third New International Dictionary of the English Language, Unabridged* (Springfield: G. & C. Merriam, 1967).
- 5. The form of the manuscript is as follows: a) name, address or affliation of the author should not appear in the MS itself; b) an abstract of approx. 10 lines should appear at the beginning of the article; c) the maximum length of the article, with footnotes, is 10,000 words; d)

complex tables, charts, maps, figures or illustrations must be supplied in a separate file as well as within the article, if possible; e) biblical verse in the original language should be initially translated into English; f) transliterations, if used, must be in a standard font such as Times New Roman or Palatino; g) American spelling is preferred, but British and other standard spellings are also accepted; h) a bibliographic section should list all cited sources in alphabetical order of the author's last name; i) any abbreviations not appearing in the SBL Handbook must be written out in full, including but not limited to journal, monograph series, and commentary series titles. 6. S&I submissions are evaluated under the following procedures: a) all submissions are blindly and confidentially evaluated and scored, each by three members of the editorial board in the most relevant area of expertise; b) upon completion of the evaluation scoring, the chief editor shall call for a meeting of all editorial board members; c) based on the scores of each article, the committee shall decide whether a submission is accepted, accepted with major or minor revisions, or rejected outright; d) the committee shall also verify whether or not a submission has been published elsewhere or is accountable for plagiarism (the committee sanctions any author guilty of plagiarism so that he/she is prohibited from submitting another article for at least 3 years); e) authors are notified via email whether the editorial board has accepted or denied an article for publication; f) articles needing revision or reformatting are sent back to the author before editing work begins (articles not returned corrected or at all forfeit the right to be published).
